A congregation should reimburse a pulpit supply person (pastor, deacon or lay person) at the rate of \$135 for a single worship service; each additional worship service should be compensated at a rate of \$35. If a class/adult forum is taught on Sunday, another \$30 should be added.

In the event the pulpit supply person is asked to preach at two separate congregations on the same day, each congregation shall be responsible for appropriate reimbursement.

Mileage should be reimbursed at the current IRS rate of 58.5¢ per mile (2022).

2023 Rates

A congregation should reimburse a pulpit supply person (pastor, deacon or lay person) at the rate of \$140 for a single worship service; each additional worship service should be compensated at a rate of \$40. If a class/adult forum is taught on Sunday, another \$40 should be added.

In the event the pulpit supply person is asked to preach at two separate congregations on the same day, each congregation shall be responsible for appropriate reimbursement.

Mileage should be reimbursed at the current 2023 IRS rate.
